MEETINGS / EVENTS CODE OF CONDUCT

Participants must understand the code of behaviour that guides their well-being at Girls Faith Club and other Schoenstatt Movement events and activities.

Parents are responsible for the transport to and fro the venue, and when they are present for family or mother/daughter events.

We expect that participants, especially children, will act respectfully to themselves, their supervisors and fellow participants. Participants must accept the ground rules of activities which supervisors will clearly explain to them.

Breaches of discipline and disruptive behaviour, including bullying, will be dealt with in a manner that is fair and transparent, by more than one Schoenstatt Events Team member. Children, or their parents, who are dissatisfied with any aspect of activities or services can follow a complaints procedure; namely, to inform Sr M Luka or any other Schoenstatt Events Team member. Phone numbers are provided on the events poster.

Rules for Bushwalking Activities:

- all participants must stay with the group at all times: they must have the assigned first or last person for the walk in view at all times
- if participants are unsure of which track to take next, they have to make sure to wait where they are and follow the team's instructions
- during the snack and lunch breaks, and other activities, participants stay in the assigned areas and do not venture into the bush on your own or as a small group
- make sure your child(ren) stay hydrated and have a water bottle with them
- for the breaks it is advised to have a warm jumper or jacket, and it might be advisable to have rain protection in case of a sudden downpour
